- J - Colombian Pastors or Christian Workers with Higher Income:** One or both parents work full-time in a Colombian church or Christian ministry (more than 40 hours a week). Neither spouse works at a secular job. Combined family income is over 12 times minimum wage/month, + 1 minimum wage/dependent child after 1st child.
- J Bi-Vocational (*):** Combined family income is 8-12 times minimum wage/month, + 1 minimum wage/dependent child after 1st child.
- K - Colombian Pastors or Christian Workers with Lower Income:** One or both parents work full-time (more than 40 hours a week) in a Colombian church or Christian ministry (including a Christian school). Neither spouse works at a secular job. Combined family income is less than 12 times minimum wage/month, + 1 minimum wage/dependent child after 1st child.
- K Bi-Vocational (*):** Combined family income is less than 8 times minimum wage/month + 1 minimum wage/dependent child after 1st child.
- L:** Special cases, by Board approval only.
- M - Foreign Missionaries:** Foreign missionaries sent by a non-Colombian mission board, with a letter from the mission for the current term on file at ECA.

***Definition of bi-vocational:** one parent serves full-time in a Christian ministry while the other works in a secular job OR the sum of both serving in ministry is 35+ hours/week or 17.5+ hours/week for single parents.
